Abbreviations stand for: OC . Open Competition, SC-Scheduled Castes, ST-Scheduled Tribe, Exs-Ex-Servicemen, PC-Physically Challenged.

02. Pay Scale & Emoluments:

The scale of pay for the post of Asst. Manager is presently Rs.15925 . 655 / 4 . 18545 . 815 / 5 . 22620 . 980 / 2 . 24580 . 1145 / 8 . 33740 . 1460 / 1 - 35200 (21 stages) +3 stagnation increments of Rs. 1460/- each biannually after reaching maximum in the scale. At present the total starting emoluments are around Rs.24,923/- per month, inclusive of DA & HRA at the current rates.

Note: Other allowances & perquisites admissible as per the rules of the Bank.

03. Eligibility criteria:

The DCC Bank has its area of operations as the District and as such all positions are within the District and suitable for Local Candidates only. Accordingly only candidates local to Sri Potti Sri Ramulu Nellore District (**candidates having domicile of Sri Potti Sri Ramulu Nellore district**) are eligible to apply for the posts. The Criterion reckoned in this regard is as under:

- a) If he / she has studied in an educational institution(s) in %local Area+above, for a period of not less than four consecutive academic years ending with the academic year in which he / she appeared or, as the case may be, first appeared for SSC or equivalent examination; or
- b) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he / she appeared or as the case may be, first appeared for the SSC or equivalent examination he / she has not studied in any educational institution(s), if he / she has resided in the %local Area+above for a

period of not less than four years immediately preceding the date of commencement of the SSC or equivalent examination in which he / she appeared or as the case may be, first appeared.

04. **AGE as on 01.10.2016** : Minimum 18 years . Maximum 30 years. **Candidates should have been born not earlier than 02.10.1986 and not later than 01.10.1998 both days inclusive.**

Note:

1. An ex-serviceman who has once joined a Government job on civil side after availing of the benefits given to him as an Ex-Serviceman for his re-employment, including a job in any Public Sector Undertaking, ceases to enjoy ex-serviceman status for further employment.
2. An Ex-Serviceman, who is discharged from service on or before **01.10.2016** is only eligible to apply.
3. Above relaxations are available only if the candidates fulfill the various conditions prescribed in the Govt. of India orders and instructions in this regard. To claim age relaxation, reserved category candidates will be required to submit a copy of the Community Certificate at the time of interview. .

Definition: Physically Challenged Persons (PC) – Definition of Categories of Disabilities:

- a) An orthopedically challenged (OC) person is one suffering from Locomotor Disability or Cerebral Palsy. Persons who suffer from not less than 40% of relevant disability (as certified by a Medical Board appointed by the Central / State Govt.) would be eligible for reservation in services / posts.

Locomotor Disability means disability of the bones, joints or muscles leading to substantial restriction of the movement of the limbs or any form of cerebral palsy.

Cerebral Palsy means a group of non progressive conditions of a person characterized by abnormal motor control posture resulting from brain insult or injuries occurring in the pre-natal, peri-natal, or infant period of development.

b) Deaf & Hearing Impaired (HI): The deaf are those persons in whom the sense of hearing is non-functional for ordinary purposes of life i.e., total loss of hearing in both ears. They do not hear, understand sounds at all even with amplified speech. Hearing impairment means loss of sixty decibels or more in the better ear in the conversational range of frequencies.

c) Visually Impaired: (VI) The visually impaired persons are those suffering from blindness or low vision.

Blindness: refers to a condition where a person suffers from any of the following conditions:

- (i) Total absence of sight,
- (ii) Visual acuity not exceeding 6/60 or 20/200 (Snellen) in the better eye with correcting lenses.
- (iii) Limitation of the field of vision subtending an angle of 20 degree or worse.

Person with low vision: means a person with impairment of visual functioning even after treatment or standard refractive correction, but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

GUIDELINES FOR PERSONS WITH DISABILITIES USING A SCRIBE

- (i) The visually impaired candidates and candidates whose writing speed is adversely affected permanently for any reason can use their own scribe at their cost during the online examination, subject to limits as in (ii) and (iii) below. In all such cases where a scribe is used, the following rules will apply:
 - " The candidate will have to arrange his/her own scribe at his/her own cost.
 - " The scribe arranged by the candidate should not be a candidate for the same examination. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably carefully indicate the same in the online application form. Any subsequent request may not be favourably entertained.
 - " A person acting as a scribe for one candidate cannot be a scribe for another candidate.
 - " The scribe may be from any academic stream.
 - " Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfill any laid down eligibility criteria or suppressed material facts the candidature of the applicant will stand cancelled, irrespective of the result of the online examination.
 - " Those candidates who use a scribe shall be eligible for compensatory time of 20 minutes for every hour of the examination or as otherwise advised.
 - " Only candidates registered for compensatory time will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible for the test conducting agency to allow such time if he / she is not registered for the same. Candidates not registered for compensatory time shall not be allowed such concessions.
 - "

(ii) Guidelines for Candidates with locomotor disability and cerebral palsy

A compensatory time of twenty minutes per hour or otherwise advised shall be permitted for the candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

(iii) Guidelines for Visually Impaired candidates

“ Visually Impaired candidates (who suffer from not less than 40% of disability) may opt to view the contents of the test in magnified font and all such candidates will be eligible for compensatory time of 20 minutes for every hour or otherwise advised of examination.

These guidelines are subject to change in terms of GOI guidelines/ clarifications, if any, from time to time.

05. Relaxation of upper age limit to the In-Service candidates of the Nellore DCCB:

The relaxation of age is upto 5 (five) years in respect of in-service candidates of the DCCB subject to the maximum age limit of 35 years for General Category (OC) and 38 years for Backward classes (BC) & 40 years for Scheduled Caste (SC) / Scheduled Tribe (ST).

06. Education Qualification (As on 01.10.2016)

Graduation in any discipline with 60% aggregate marks, or Commerce Graduate with 55% aggregate marks (+) Computer Knowledge
and
Knowledge of English and proficiency in local language (Telugu) is essential.

Note: The percentage of marks in graduation shall be arrived at by dividing the aggregate/total marks obtained by the candidate in all subjects, as graded by the concerned University/Board, with the aggregate maximum marks of the examination passed for all the years of the examination. In case, the Universities or Boards award marks in the form of Grades, such Grades will be considered to the equivalent percentage specified above as per the rules of the Universities or Boards.

1) Desirable: Proficiency in Telugu language.

2) Knowledge of English is required.

3) Preference will be given to candidates with computer knowledge (as per assessment at the time of interview).

07. Selection Procedure:

The selection of the candidates shall be made on the basis of on-line test and interview. The on-line test will be conducted in English. All the eligible candidates who apply with the requisite fee and whose applications are received in time will be called for a on-line test, which will comprise the following.

a) On-line test marks : 100 marks & Interview . 25 marks

b) There shall be **Negative Marking for wrong answers.**

Marks obtained in the on-line test will be reckoned for merit ranking. Accordingly, candidates will be called for interview. Depending upon the number of vacancies only those candidates who rank sufficiently high in the on-line test will be called for the interview in the ratio of 1:4. Mere eligibility / pass in the test shall not vest any right for being called for interview. The detailed information regarding the on-line test “**Acquaint yourself**” which is available on the Bank's website. <http://www.nelloredccb.com> which can be downloaded by the candidates.

Final selection will be on the basis of the ranking accorded, after adding the marks obtained in the on-line test and interview.

08. On-line Test:

The on-line test will be held **TENTATIVELY** in the month of November / December 2016.

The date of examination is tentative. The exact date will be communicated to the candidates through call letter for the examination. The Bank, however, reserves the right to cancel or make any change in the date of examination, as per need.

The on-line test will be held in the following venues

The examination will be conducted online in venues given in the respective call letters.

No request for change of centre/venue/date/session for Examination shall be entertained.

Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd., however, reserves the right to cancel any of the Examination Centers and / or add some other Centers, at its discretion, depending upon the response, administrative feasibility, etc.

Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd., also reserves the right to allot the candidate to any centre other than the one he/she has opted for.

Candidate will appear for the examination at an Examination Centre at his/her own risks and expenses and Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd., will not be responsible for any injury or losses etc. of any nature.

Choice of centre once exercised by the candidate will be final.

09. Appointment:

Candidates selected for current vacancies shall be taken into the service in the descending order of merit cum roster as per the requirement. The candidate, upon selection, would have to execute a Contract Bond, that, he / she would serve the Bank for a minimum period of 2 years or **in lieu of Rs.2,00,000/- payment to Bank.**

Candidates can apply online only from 14-10-2016 to 28-10-2016 and no other mode of application will be accepted.

IMPORTANT POINTS TO BE NOTED BEFORE REGISTRATION

Before applying online, candidates should-

- i. Scan their photograph and signature ensuring that both the photograph and signature adhere to the required specifications as given under Guideline for photograph & signature scan and upload.
- ii. Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. Bank may send intimation to download call letters for the Examination etc. through the registered e-mail ID. In case a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID and mobile no. before applying on-line and must maintain that email account and mobile number.

A. Application Procedure

1. Candidates to go to the **Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd.**, website **www.nelloredccb.com** click on the option "**APPLY ONLINE**" which will open a new screen.
2. To register application, choose the tab "**Click here for New Registration**" and enter Name, Contact details and Email-id. A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
3. In case the candidate is unable to complete the application form in one go, he / she can save the data already entered by choosing "SAVE AND NEXT" tab. Prior to submission of the online application candidates are advised to use the "SAVE AND NEXT" facility to verify the details in the online application form and modify the same if required. Visually Impaired candidates should fill the

application form carefully and verify/ get the details verified to ensure that the same are correct prior to final submission.

4. Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible/ entertained after clicking the FINAL SUBMIT BUTTON.
5. The Name of the candidate or his /her Father/ Husband etc. should be spelt correctly in the application as it appears in the Certificates/ Mark sheets/Identity proof. Any change/alteration found may disqualify the candidature.
6. Validate your details and Save your application by clicking the 'Validate your details' and 'Save & Next' button.
7. Candidates can proceed to upload Photo & Signature as per the specifications given in the Guidelines for Scanning and Upload of Photograph and Signature detailed under point "C".
8. Candidates can proceed to fill other details of the Application Form.
9. Click on the Preview Tab to preview and verify the entire application form before FINAL SUBMIT.
10. Modify details, if required, and click on 'FINAL SUBMIT' ONLY after verifying and ensuring that the photograph, signature uploaded and other details filled by you are correct.
11. Click on 'Payment' Tab and proceed for payment.

ONLINE MODE

1. The application form is integrated with the payment gateway and the payment process can be completed by following the instructions.
2. The payment can be made by using Debit Cards (RuPay / Visa / Master Card / Maestro), Credit Cards, Internet Banking, IMPS, Cash Cards/ Mobile Wallets.
3. After submitting your payment information in the online application form, PLEASE WAIT FOR THE INTIMATION FROM THE SERVER. DO NOT PRESS BACK OR REFRESH BUTTON IN ORDER TO AVOID DOUBLE CHARGE
4. On successful completion of the transaction, an e-Receipt will be generated.
5. Non-generation of 'E-Receipt' indicates PAYMENT FAILURE. On failure of payment, Candidates are advised to login again using their Provisional Registration Number and Password and repeat the process of payment.

6. Candidates are required to take a **printout of the e-Receipt** and online Application Form. **Please note that if the same cannot be generated, online transaction may not have been successful.**

C) Guidelines for scanning the photograph and Signature:

Before applying online a candidate will be required to have a scanned (digital) image of his / her photograph and signature as per the specifications given below.

(I) Photograph image:

- Photograph must be recent passport size colour picture.
- The picture should be in colour, against a light-coloured, preferably white background.
- Look straight at the camera with a relaxed face.
- If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows.
- If you have to use flash, ensure there is no red-eye.
- If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200x 230 pixels (preferred).
- Size of file should be between 20kb-50kb.
- Ensure that the size of the scanned image is not more than 50 kb. If the size of the file is more than 50 KB, then adjust the settings of the scanner such as the DPI resolution, No. of colors etc., during the process of scanning.

(II) Signature image:-

- The applicant has to sign on white paper with Black Ink Pen.
- The signature must be signed only by the applicant and not by any other person.
- The signature will be used to put on the Attendance Sheet and wherever necessary.
- The applicant's signature obtained on the call letter and attendance sheet at the time of the examination should match the uploaded signature. In case of mismatch, the applicant may be disqualified.
- Dimensions 140x60 Pixels (Preferred)

- Size of file should be between 10kb-20kb
- Ensure that the size of the scanned image is not more than 20KB.
- Signature in **CAPITAL LETTERS** shall **NOT** be accepted.

(III) **Scanning the Photograph & signature:**

- Set the scanner resolution to a minimum of 200 dpi (dots per inch).
- Set color to True color
- File size as specified above
- Crop the image in the scanner to the edge of the photograph / signature, then use the upload editor to crop the image to the final size (as specified above).
- The image file should be JPG or JPEG format. An example file name is image01.jpg or image01.jpeg.
- Image dimensions can be checked by listing the folder files or moving the mouse over the file image icon.

Candidates using MS Windows / MS Office can easily obtain photo and signature in .jpeg format not exceeding 50kb & 20 kb respectively by using MS Paint or MS Office Picture Manager. Scanned photograph and signature in any format can be saved in .jpg format by using **Save As+** option in the File menu and size can be reduced below 50 kb (photograph) & 20 kb (signature) by using crop and then resize option (please see point (i) & (ii) above for the pixel size) in the **Image** menu. Similar options are available in other photo editor also.

If the file size and format are not as prescribed, an error message will be displayed.

While filling in the Online Application Form the candidate will be provided with a link to upload his / her photograph and signature.

Procedure for uploading the Photograph and Signature:

- (i) There will be two separate links for uploading photograph and signature.
- (ii) Click on the respective link **Upload Photograph / Signature+**
- (iii) Browse & Select the location where the Scanned photograph / Signature file has been saved.
- (iv) Select the file by clicking on it.
- (v) Click the **Open / Upload+** button.

Your Online Application will not be registered unless you upload your photograph and signature as specified.

Note:-

- (i) In case the face in the photograph or signature is unclear, the candidate's application may be rejected. After uploading the photograph / signature in the On-line application form candidates should check that the images are clear and have been uploaded correctly. In case the photograph or signature is not prominently visible, the candidate may edit his / her application and re-upload his / her photograph or signature, prior to submitting the form.

DOWNLOAD OF CALL LETTER

Candidates will have to visit the Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd., website for downloading call letters for online test. Intimation for downloading call letter will also be sent through email/SMS. Once the candidate clicks the relevant link, he/she can access the window for call letter download. The candidate is required to use (i) Registration Number/Roll Number, (ii) Password/Date of Birth for downloading the call letter. Candidate needs to affix recent recognizable photograph on the call letter preferably the same as provided during registration and appear at the examination centre with (i) Call Letter (ii) Photo Identity Proof as stipulated in clause (xiii) below and also specified in the call letter and photocopy of the same Photo Identity Proof as brought in original.

CANDIDATES REPORTING LATE i.e. after the reporting time specified on the call letter for Examination will not be permitted to take the examination. The reporting time mentioned on the call letter is prior to the Start time of the test. Though the duration of the examination is **60 minutes**, candidates may be required to be at the venue for about 3 hours including the time required for completion of various formalities such as verification and collection of various requisite documents, logging in, giving of instructions.

IDENTITY VERIFICATION

In the examination hall as well as at the time of interview, the call letter along with original and a photocopy of the candidate's currently valid photo identity (bearing exactly the same name as it appears on the call letter) such as PAN Card/ Passport/ Driving Licence/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazetted Officer on official letterhead along with photograph / Photo identity proof issued by a People's Representative on official letterhead along with photograph / valid recent Identity Card issued by a recognized College/ University/ Aadhar / E-Aadhar card with a photograph/ Employee ID/ Bar Council Identity Card with photograph should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination.

Ration Card are **not** valid id proof for this project.

Note:

- 1) Candidates have to produce in original the photo identity proof and submit photocopy of the photo identity proof along with Examination call letter as well as the Interview Call Letter while attending the examination/ interview respectively, without which they will not be allowed to take up the examination/ interview. Candidates must note that the name as appearing on the call letter (provided during the process of registration) should exactly match the name as appearing on the photo identity proof. Female candidates who have changed first/last/middle name post marriage must take special note of this. If the examination is held in more than one session, the scores across various sessions will be equated to adjust for slight differences in difficulty level of different test batteries used across sessions. More than one session are required if the nodes capacity is less or some technical disruption takes place at any center or for any candidate.

Instances for providing incorrect information and/or process violation by a candidate detected at any stage of the selection process will lead of disqualification of the candidate from the selection process and he/she will not be allowed to appear in any Sri Potti Sri Ramulu Nellore District Cooperative Central Bank Ltd., recruitment process in the future. If such instances go undetected during the current selection process but are detected subsequently, such disqualification will take place with retrospective affect.

At the time of on-line examination / interview or in a subsequent selection procedure, if a candidate is (or has been) found guilty of . (i) using unfair means or (ii) impersonating or procuring impersonation by any person or (iii) misbehaving in the examination / interview disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose or hall or taking away the question booklet (or any part thereof) / answer sheet from the examination hall or (iv) resorting to any irregular or improper means in connection with his / her candidature for selection or (v) obtaining support for his / her candidature by unfair means, or (vi) carrying mobile phones or similar electronic devices of communication in the examination / interview hall, such a candidate may, in addition to rendering himself / herself liable to criminal prosecution, be liable:

CANDIDATES REPORTING LATE i.e. after the reporting time specified on the call letter for Examination will not be permitted to take the examination. The reporting time mentioned on the call letter is prior to the Start time of the test.

Process for Arriving at

The Scores of Online Examination are obtained by adopting the following procedure:

- (i) Number of questions answered correctly by a candidate in each objective test is considered for arriving at the Corrected Score after applying penalty for wrong answers.
- (ii) The Corrected Scores so obtained by a candidate are made equivalent to take care of the minor difference in difficulty level, if any, in each of the objective tests held in different sessions to arrive at the Equated Scores*

* Scores obtained by candidates on any test are equated to the base form by considering the distribution of scores of all the forms.

(iii) Test wise scores and scores on total is reported with decimal point upto two digits.

Note: Cutoffs are applied in two stages:

- i. on scores in individual tests
- ii. on Total Score
